An Introduction to the environmental problems and challenges facing mankind. Global problems will be directly related to issues facing the regional and local environment. The course covers environmental problems and their causes, ecosystems and how they work, deforestation, loss of biodiversity, species extinction, air, water and soil pollution, ozone depletion, solid waste disposal, renewable energy technologies, and applications to alleviate environmental problems. Case studies will be presented and potential solutions will be emphasized. The course also includes field trips.

POLICY ON CHEATING AND PLAGIARISM

Students caught cheating on an exam receive a grade of zero on the exam in their first cheating attempt and receive a warning. Students caught cheating for the second time will receive a grade of "F" in the course and another warning. Plagiarism on assignments and project work is a serious offense. If plagiarism is detected, a student will be subject to penalty, similar to the cheating case, which ranges from receiving a zero on the assignment concerned to an "F" in the course in addition to a warning.

ATTENDANCE POLICY

- 1. Students are expected to attend all classes.
- 2. For valid reasons, students may miss classes for a maximum that is equivalent to two regular semester weeks (or one summer week).
- 3. When exceeding the maximum number of absences, it is the instructor's prerogative to ask the concerned student to stop attending and drop the course. In this case, it is the student's responsibility to drop the course; otherwise a grade of "F" or "NP" will be given.
- 4. In exceptional justified cases (long illness, etc...), where absences exceed the maximum, the student has to petition to the department Chair to be allowed to stay in the course.



5. Students are held responsible for all the material presented in the classroom, even during their absence

PHONE USE POLICY

According to the Student Code of Conduct:

2.1.17. Using cellular phones and other devices in classrooms, laboratories, or studios **during classes** or examinations without the permission of the course instructor.

The instructor has the right to report your name to the Dean of Students for the mere fact you are touching it (during lecture or exam) regardless of the reason.

Regarding touching your phone, it is worth noting that:

- 1) Instructors do not need to bother themselves with the hassle of providing evidence. The fact that the phone is on the seat, it's an immediate "F" on the exam. The phone must not be on the desk, seat, or in the student's hand, period. Instructors/proctors cannot and should not guess why it's there or why the student is touching the phone, be it for checking the time out, finding out who called, or reading a message.
- 2) Although the instructor/proctor can't take the student's phone as there could be personal photos or material since it's the student property, this property cannot be touched during class or exam time, according to the Student Code of Conduct. Thus,
- 3) The student is guilty by merely touching the phone.

Save yourself the Warning and don't touch your phone.

WITHDRAWAL POLICY

- 1. A student who withdraws after the Drop/Add period and by the end of the 5th week of classes (10th day of classes for Summer Modules) will obtain a "WI" on that particular course. The student may process such request directly through the Registrar's Office.
- 2. A student who withdraws from a course between the 6th week and the end of the 10th week of classes (18th day of classes for Summer Modules) will receive either a "WP" or a "WF". "WP" or "WF" will be determined by the instructor based on the achieved academic performance in that course till the time of withdrawal.
- 3. The "WI" and the "WP" will not count as a Repeat; whereas the "WF" will count as a Repeat.
- 4. "WI", "WP" and "WF" will not count towards the GPA calculation.

SPECIAL NOTES

Class participation is welcome especially in presenting problems for discussion and suggesting potential speakers. Students coming more than 10 minutes late may not be allowed into the class or counted as absent.

Students are expected to have a copy of the notes with them in class. This will help them write down notes of items discussed in class that may be an expansion on the material or a different case study than that in the notes. Course notes and some supplementary material will be available on BlackBoard Learn for students' perusal.

Scheduled field trips will constitute part of the course. Missing a fieldtrip will be equivalent to two absences. Due to the nature of fieldtrips, students are expected to obey classroom rules during these trips. Smoking in the bus will not be tolerated but may be allowed during rest stops. Students leaving the group at any point during the fieldtrip do so at their own risk and may be issued a warning. Students may be allowed off the bus on the way back at the discretion of the class instructor.

Use of cellular phones in any form will not be tolerated in class and during exams. Such use may result in student's dismissal from class.

Notes on exams:

There will be no make-ups for missed exams. A missed exam will receive a grade of zero. Exams are multiple-choice questions about all the material discussed in class including videos and visiting speakers. All exam grades count and none will be dropped. Students are required to bring their ID's to exams. Exams missing the student's name will receive 10 grades deduction. Phones should be off and not visible during exams.
